On March 8th, 2020, I was dispatched to 11310 Donnington Drive regarding a domestic dispute.

Upon my arrival, I spoke to the victim, BODKER, LISA -85) (wife) who stated that her husband/arrestee, BODKER, MICHAEL -65), came upstairs to exchange their child and he grabbed her wrist and ankle causing visible redness. The victim stated that she records her husband exchanging their child with her phone as they are going through a divorce. The victim alleged that her husband became upset with her recording him and he grabbed her ankle and wrist to stop her from recording him.

The victim showed me the video and I examined the incident. I was able to see the arrestee bringing the crying child into the bedroom. The victim (mother) appears to be sitting upright in the large bed and is recording the arrestee. The arrestee places the crying child near the victim. It appears that the arrestee is bent over the side of the bed and the side of his head is near the phone. At this point, the arrestee shouts, "get it out of my face." The phone appears to be knocked to the side and the victim yells "don't touch me!" The phone then refocuses and I could see the arrestee walking out of the room telling the victim, "don't ever shove that into my face" while the victim yells "don't touch me!" and "you don't shove me!"

The victim provided me with photos of her ankle and wrist that she stated she took before the police arrived. The photos did show slight pinkness of the skin but no major injury. I took no photos of the victim as she had no visible injuries as she spoke to me.

My supervisor (Sgt. O'Hagan) and I spoke to the arrestee and he stated that his wife (victim) records him and tries to get a reaction out of him. The arrestee stated that he brought the child up to her mom's bed and her mom started berating him while holding her phone very close to his face while he was attempting to keep the child from falling off the bed. He stated that he then asked her to get the camera out of his face. He then put his hand on her wrist to push her arm and camera from being so close to his face.

Both parties provided signed written statements telling their side of the dispute. Neither party was in custody at the time. All statements were provided free and voluntary. I entered these statements into the record's inbox.

The victim was sent an Evidence.com link and she sent me the video and photos. I approved these photos and they were triaged to the case.

The arrestee was handcuffed (double locked) and placed into custody. I transported him to the Alpharetta Jail without incident or injury.

Based on the video, photos, and testimonial evidence, the arrestee was charged with one count of O.C.G.A. 16-5-23(f)-(Simple Battery - FV). Citation # E107415 was used.

A Fulton County Electronic Warrant was obtained, Warrant # EW-0294363, signed by Judge Manning, Magistrate Court of Fulton County. A State of Georgia Uniform Citation, Accusation & Summons form was completed by myself and notarized by Sgt. O'Hagan. One copy was given to the jail and the other to the arrestee.

The jail refused to take the arrestee's two cell phones, electronic watch, and a Bluetooth earpiece. This property was turned over to Sgt. O'Hagan who logged the property for retrieval.
